| Single membership | Available to a person who has attained the age of 18 years. <ul style="list-style-type: none"> • A single member receives the ACDS Journal • A single member has voting rights and are eligible to hold Office at Club, Branch and Federal levels. |
| Junior membership | Available to a person who has not attained the age of 18 years, and who is not the child of a member. <ul style="list-style-type: none"> • A junior member receives the ACDS Journal • A junior member does not have voting rights and is not eligible to hold Office at Club, Branch and Federal levels. |
| Associate | Available to persons of any age who do not drive horses/ponies. <ul style="list-style-type: none"> • An associate member receives the ACDS Journal • An associate member does not have voting rights and is not eligible to hold Office at Club, Branch and Federal levels. |
