INFORMATION ON CATEGORIES OF MEMBERSHIP

Family Membership Available to persons being either one of the following:

- The spouse or defacto spouse of a member or one additional adult person (aged 18 years or over) in family or defacto relationship living at the same household (Family Member); or
- A child or grandchild of a member who has not attained the age of 18 years (Family Junior Member).
- Members of the Family membership receive the ACDS Journal
- Adult members in the aforementioned membership categories have voting rights and are eligible to hold Office at Club, Branch and Federal levels.

Single Membership Available to a person who has attained the age of 18 years.

- A single member receives the ACDS Journal
- A single member has voting rights and are eligible to hold Office at Club, Branch and Federal levels.

Junior Membership Available to a person who has not attained the age of 18 years and who is not the child of a member.

- A junior member receives the ACDS Journal
- A junior member does not have voting rights and is not eligible to hold Office at Club, Branch and Federal levels.

Associate

- Available to persons of any age who do not drive horses/ponies.
- An associate member receives the ACDS Journal
- An Associate member does not have voting rights and may not be an Office Bearer at Federal Level. In accordance with ACDS By-Law 2.11 an Associate Member may hold office at a State Branch or Club (subject to compliance with the relevant Branch or Club Rules).
